

For over 28 years, Great Waters has animated the cultural life of our region. Founded in 1995, Great Waters is a nonprofit organization dedicated to culturally enriching New Hampshire's Lakes Region.

Concerts in the Clouds are performed at Shannon Pond at Castle in the Clouds under a large tent with additional outside lawn seating. Concerts in Town are held at indoor venues in Wolfeboro.

Great Waters also focuses on educational outreach, offers scholarships, and provides community enrichment, inclluding our Street Pianos which are available all summer for the public to enjoy.

In 2023, we entertained over 3,500 patrons (up by 35% from the previous year), had hundreds of people tickle the keys throughout downtown Wolfeboro on our Street Pianos, and gave out \$10,000 in student scholarships. Our patrons come from throughout New England, with highest local attendance from Wolfeboro, Moultonborough, Mirror Lake, Meredith, Tuftonboro, Laconia, Alton, Gilford, Center Harbor, Ossipee, Melvin Village, and Sandwich.

- On a brochure or mailing

Use of the emblem is prohibited in the following instances:

- The emblem is the exclusive property of Great Waters. Any unauthorized use or reproduction that does not conform to that described in these guidelines is expressly prohibited.
- While the emblem may promote a company's support, it must never be used to advertise or endorse products or services.
- The emblem may not be used in conjunction with, assimilated into, or merged with another design or trademark.
- The emblem may not be used after the expiration date has passed.

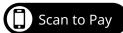
